1. ADFIAP's<sup>1</sup> <u>www.adfiap.org</u> four (4) key areas of work and advocacy, under its broad mission of "financing sustainable development", are: micro, small and medium enterprise (MSME) finance (*economic*), green finance (*environment*) and financial inclusion (*social*) with good governance at its core or, in short, its EESG "pillars". ADFIAP believes that its member-development finance institutions (DFIs) or, alternatively called development banks, are the "natural" institutions to pursue and promote national sustainable development efforts through the provision of long-term finance and technical assistance.

2. 3. With regard to financial inclusion, ADFIAP has co-organized two (2) events in 2011:
