ISSUE Draft agenda of the Workshop on Innovative Financing for SMMEs

BACKGROUND In 2014, ABAC and the SME Finance Forum produced the report "APEC Framework for Innovative SMME Financing Mechanisms." It called for:

- more government actions with regard to equity-based financing mechanisms for SMMEs, such as support for business angels, seed capital, and venture capital;
- regulatory review to remove barriers to SMME access to new, Internetbased trade and supply chain financing platforms (including crossborder platforms);
- regulatory review to facilitate new SMME access to crowdfunding facilities;
- regulatory review to encourage small-cap exchange and exchange window development more suited to SMMEs; and
- regulatory review to ensure that major financial participants that have a longer term outlook and higher risk profile, including high net worth individuals, family trusts, insurance companies, pension funds, and other endowments, are not discouraged from participating in investment vehicles based on well-documented SMME loan and other pooled SMME finance assets.

PROPOSAL The workshop seeks to advance discussions on these recommendations and identify concrete ways for APEC to implement them.
