### **BACKGROUND**

As noted at the Guangzhou meeting, AASC will be convening a symposium in coordination with the Association of Development Financing Institutions in Asia and the Pacific (ADFIAP) to support APEC's work on Financial Inclusion. The symposium will be convened in Manila, 27/28<sup>th</sup> June. It will be followed in the 3<sup>rd</sup> Qtr by a workshop in Melbourne. Representatives of regional policy and regulatory agencies, banks and financial institutions and standard setting bodies will be invited to participate in the symposium to consider regulatory and policy challenges faced in the provision of finance to MSMEs. The outcome of the work will best practice proposals for regulatory and supervisory approaches to facilitate the provision of finance to MSMEs and thereby promote financial inclusion.

This work responds to a G20 proposal that there should be proportionate regulatory and supervisory frameworks in relation to sources of MSME finance.

#### ***Major themes of the Manila symposium will be:***

- Regional and global concerns, challenges and opportunities with MSME finance
- The promotion of a regulatory and supervisory environment in regional economies that would increase the flow of funds to MSMEs through banking systems and capital markets

The Advisory Group in Guangzhou agreed that this work was an integral contribution to its work on financial inclusion in 2011.
