The proposed 2007 work program consists of a project (see Item 3 below) and the development of specific capacity-building proposals in a number of key areas, which are as follows: (1) development of bond markets; (2)implementing Basel II and strengthening risk management; (3) strengthening governance in financial systems; (4) enhancing financial consumer protection; (5) strengthening the frameworks for cross-border insolvency and informal workouts in the region; (6) promoting financial stability, especially with respect to volatile capital flows; and (7) enhancing SMEs' capacity to access formal finance. In addition, it is proposed that the Advisory Group consider whether to undertake work on (1) remittance systems and (2) combating money laundering and terrorist finance.
